
In view of the urgency to implement the said projects, Schools Division Offices are hereby advised to proceed with the procurement activities short of awarding upon receipt of this Authority to Procure (ATP). The Head of the Procuring Entity (HOPE) must submit the approved Resolution to Award (RTA) to the Education Facilities Division (EFD) of the Central Office (CO) as basis for the downloading of the sub-SARO.

The sub-SARO will be release by the Central Office directly to the Regional Offices (RO) concerned. Upon receipt by the RO, it shall then process the issuance of sub-SARO to the respective Division Offices (DO) following the listing attached in the sub-SARO. The Ros are given one (1) week to process the sub-allotments to DOs.

The revised guidelines in the implementation of the Electrification Program of school buildings should still be applied and complied with.

Immediate dissemination of and strict compliance with this Memorandum is directed.
