The Bureau of Learner Support Services-School Health Division (BLSS-SHD) extends the invitation from HealthJustice Philippines to the selected participants from the Department of Education (DepEd) for the webinar titled, "Tobacco Industry Interference in the Philippines During COVID-19," on 26 June 2020 at 4:00 pm.
