DEPED COMMONS UPDATES

DepEd Commons, one of the Department of Education's response to distance learning during the pandemic, has enjoyed its sustained success since its launch last March 14, 2020.

For the month of August, it has welcomed 323,956 new users, of which 23,803 are returning users. Currently, **DepEd Commons has over 8.64 Million as of September 15, 2020.**

Based on data from Google Analytics, DepEd Commons has also been accessed through a variety of channels, mostly through Google Search and Facebook, and other external websites. Not surprisingly, **nearly 3/4 of DepEd Commons users are accessing it direct from Google Search or directly typed on their browsers (73%),** with only 3% from Facebook.

DepEd, through the Office of the Undersecretary for Administration (OUA), has overseen the continuous development of DepEd Commons. A few major developments include:

1. Migrating the list of Schools (both Public and Private) to identify geographic locations, instead of the user's identity;
2. Zero-rating with telecommunications company, allowing free access of the DepEd Commons domain on mobile data;
3. Added categories, grading periods, and levels; and
4. User-friendly user interface (UI) to allow easy navigation

Currently, DepEd is encouraging all users to register their own DepEd Commons accounts, in order to help the Department better analyze data and usage.
